

# COUNTY OF SONOMA DRIVING UNDER THE INFLUENCE PROGRAM

## DUI PROGRAM ORIENTATION AND ENROLLMENT INFORMATION (REV. 03/2019)

To enroll in the Driving Under the Influence Program you must first attend an orientation by 21 days of your DUI sentencing date per the Sonoma County Superior Court. Failure to comply with the 21-day enrollment requirement may result in a court-issued bench warrant for your arrest. Full program enrollment requires completing a two-step process: 1) attending an orientation; and 2) completing an intake appointment. **YOU MUST COMPLETE BOTH STEPS TO BE FULLY ENROLLED.**

Orientations are held on **Wednesday and Thursday afternoons ONLY** (except on County holidays) at the ORENDA CENTER, 1430 NEOTOMAS AVENUE, SANTA ROSA STARTING ON WEDNESDAY, MARCH 20, 2019:

- **WEDNESDAY AFTERNOON:** DOOR OPENS AT 12:00 PM FOR PAPERWORK PROCESSING AND IS CLOSED PROMPTLY AT 1:00 PM. Orientation is held between 1:00-2:00 PM. A sign-up list for same day intakes is placed in lobby by 10:00 AM.
- **THURSDAY AFTERNOON:** DOOR OPENS AT 4:00 PM FOR PAPERWORK PROCESSING AND IS CLOSED PROMPTLY AT 5:00 PM. Orientation is held between 5:00-6:00 PM. A sign-up list for same day intakes is placed in lobby by 2:00 PM.

**WE CANNOT ADMIT YOU AFTER THE DOOR IS CLOSED.** No appointment is necessary. A limited number of program intakes begin immediately after orientation on a first come, first serve basis. Only the first few people on the sign-up list will have intake appointments the same day as orientation. **PLEASE NOTE: THE NUMBER OF INTAKES CONDUCTED IS DEPENDENT ON STAFF AVAILABILITY.** The remaining individuals will schedule an intake appointment for a later date. **You are not fully enrolled in a DUI program until you complete an intake appointment. A Proof of Enrollment Certificate, required to obtain a restricted license, will NOT be issued from the DMV until you complete an intake.**

To attend an orientation, you **MUST** provide **HARD COPY** of required paperwork, either a court referral (given to you at sentencing) or a DMV H-6 (your 10-year driving record), or you will be turned away. The H-6 is only available by going **IN PERSON** to any local DMV branch office and **CANNOT** be obtained or printed online. **WE DO NOT ACCEPT ELECTRONIC COPIES OF REQUIRED PAPERWORK. MINIMUM PROGRAM DOWN PAYMENTS ARE REQUIRED FOR ALL CLIENTS AT INTAKE.** You **MUST** bring the minimum down payment to your intake appointment or we cannot enroll you. Payments must be made by cashier's check, money order, VISA or MasterCard (credit or debit OK). **WE DO NOT ACCEPT CASH, PERSONAL CHECKS OR BUSINESS CHECKS.** If you have any questions, please call (707) 565-7640. **FOR MORE INFORMATION, GO TO: [www.sonoma-county.org/dui](http://www.sonoma-county.org/dui)**

### **REQUIRED MINIMUMS FOR PROGRAM DOWN PAYMENTS:**

- \$178.00 – 6 weeks Wet and Reckless (WR); \$356.00 program cost
- \$431.00 – 3 months First Offender (FOP); \$863.00 program cost
- \$505.00 – 6 months Extended First Offender (EXT-6); \$1,260.00 program cost
- \$551.00 – 9 months Extended First Offender (EXT-9); BAC .20 or above, or a refusal; \$1,719.00 program cost
- \$389.00 – 12 months Multiple Offender (MOP-12; per DMV, last DUI in 1990-91); \$1,945.00 program cost
- \$425.00 – 18 months Multiple Offender (MOP-18); \$2,123.00 program cost
