THIS ACTION IS BEING TAKEN UNDER THE AUTHORITY OF SECTION 13365 OF THE VEHICLE CODE (V.C.) BECAUSE YOU VIOLATED YOUR WRITTEN PROMISE TO APPEAR AND/OR YOU FAILED TO PAY A FINE PURSUANT TO SECTION 42003(A) V.C. (SEE ENCLOSED LETTER).
